Individual Training Plan	three years and the degree can obtained after having acquired <u>at least 30</u>
	credits (180 hours) for training through courses and attendance at a
	minimum of twelve (12) seminars during the three years. The PhD student
	must also carry out independent and original research, culminating in the
	writing of the thesis. The publication of the results in ISI journals is strongly
	encouraged.
	There are compulsory courses that a PhD student must take, and the student
	can then independently create, in agreement with his/her supervisor, his/her
	own Individual Training Plan.

Training Plan	
1) Definition of course	A course is defined as a class (taught in Italian or in English) with a number of
_,	teaching hours typically equal to or greater than 6 (six), divided into two or
	more separate days. Courses held at other universities may be given in other
	languages and have a different duration. The acquisition of the training
	credits by the student is obtained by presenting a certificate of attendance
	signed by the lecture. For the courses organized by the Doctoral course, the
	PhD Student will be required to fill in an evaluation form at the end of the
	course. PhD students have to attend at least 75 % of the course. Courses
	offered by the Doctoral Course in Geosciences are taught in English.
2) Definition of seminar	seminar is defined as a presentation with a limited duration (typically one
	hour or even less), after which no formal exam is given. The seminar is given
	by qualified personnel on topics of high specialization and advanced research
	(of a technical-scientific subject or regarding soft skills).

c) Soft skills courses	PhD students must take soft skills courses to complete their training
	obligations. These are:
	-The PhD student in the research world (18 hours - 3CFU)
	-Scientific English for Ph.D. Geosciences Students 20 hours (3.3 CFU)
	-ABC Bibliographic Research in Geosciences (10 hours – 1.7 CFU)

d) Seminars	PhD students must attend a minimum of 12 seminars (over the three years) to
	complete their educational obligations.
	The seminars include those organized by the Department of Geosciences for
	which we have an on-line system to certificate your attendance: More info

	However, seminars organized by other Departments (Italian and foreign) can
	be included if you have a certificate of attendance.
	Upon completion of this training activity, 2 credits (12 hours) will be awarded.
e) Group activities	These activities are not valid for the completion of the training obligations.
f) Schools	PhD students can participate in Schools to complete their educational
	obligations. The certified attendance to courses offered within national or
	international Schools can be assigned a number of CFU equal to 1 (one) every
	6 (six) hours of frontal teaching. A student can obtain a maximum of 12
	(twelve) CFU by participating in one or more national or international Schools.
g) Other training activities	PhD students can participate to other types of educational activities to
	complete their educational obligations. It is possible to partially meet the
	training obligations by attending any classes in the framework of
	courses/events organized by highly qualified professional associations.
h) Participation to	The attendance of PhD students to conferences/workshop is warmly
conferences	suggested but these activities are not valid to complete their educational
	obligations.
